RE: ADDENDUM NO. 1

TENDER NO. KPA/019/2025-26/SCM – SUPPLY OF STAFF UNIFORMS (RESERVED FOR PREFERENCE GROUPS)

===== Pursuant to clause 7.1 of the tender document, the Authority hereby issues the following additional information: -

- i. Bidders shall NOT be required to submit samples of uniforms listed under xi of the Preliminary examination for Determination of Responsiveness.
- ii. Bidders shall be required to view samples at the Mombasa Central Stores from **Monday 16th March 2026 to Thursday 19th March 2026 between 0900hours and 1500hours (Mandatory).**
- iii. Bidders shall be required to submit a written undertaking that when awarded the contract, they shall supply the uniforms as per the Authority’s approved Samples and Quality Standard Specifications provided in the tender document **(Mandatory).**
- iv. The tender is open to Youth, Women and People with Disability (PWD). Under Section III Evaluation and Qualification Criteria item iv should read Valid AGPO Certificate issued by the National/County Treasury. **(Mandatory)**
- v. Below is an additional clause to SECTION VII - SPECIAL CONDITIONS OF CONTRACT:

GCC 13.1	<p>All deliveries shall comply with the standards of the Authority’s approved sample and Quality Standard Specifications provided in the tender document.</p> <p>All designs work (pre-production samples) for the uniforms shall be subject to approval and signoff by the Contract Implementation Team (CIT) before final production and subsequent delivery. Supply of full order will be subject to approval of a uniform physical sample as per specifications provided in the tender document.</p> <p>Sub-standard items shall be rejected at the Supplier’s cost.</p> <p>Deliveries shall be as and when required to Mombasa Central Stores, ICD Nairobi, Kisumu Port, Lamu Port or any other point of delivery as may be directed from time to time.</p>

Uniforms not meeting the Authority's approved samples and Quality Standard Specifications shall be rejected at the Contractor's expense.

The Contract Performance shall be reviewed on Quarterly Basis.

Subsequently the closing date has been extended to **"BEFORE 1000HOURS ON THURSDAY 26TH MARCH 2026"**.
