Pursuant to clause 7.1 of the tender document, the Authority hereby issues the following additional information: -

- i. Bidders shall NOT be required to submit samples of uniforms listed under xii of the Preliminary examination for Determination of Responsiveness.
- ii. Bidders shall be required to view samples at the Mombasa Central Stores from **Monday 16th March 2026 to Thursday 19th March 2026 between 0900hours and 1500hours (Mandatory).**
- iii. Bidders shall be required to submit a written undertaking that when awarded the contract, they shall supply the uniforms as per the Authority’s approved Samples and Quality Standard Specifications provided in the tender document **(Mandatory).**
- iv. Below is an additional clause to SECTION VII - SPECIAL CONDITIONS OF CONTRACT:


